

#### **New Arboc** Buses.

The three buses are on construction line and will be completed by the end of March. The buses will be shipped at the first of April.





### **Bus Stop** Signage

The signage project is continuing in the copper route. The Red and Turquoise routes are now complete. The next route to repair will be the silver. Our goal is to continue with the refurbishment of the signs and shelters route by route to complete all of the Lines by fall of 2023.

#### **Future Service** changes.

One of our objectives for FY2023 is to expand and add service. The proposal is to connect the Purple route with the westside transfer station via Country club instead of Sunland Park City Hall. The Yellow route would connect to the purple route at McNutt and Country Club. A second option would be the Purple route travels to the Westside Transfer Center versus Sunland Park City Hall. Another objective is to add service to Sierra County by fall of 2023. This route may operate with limited stops within Elephant Butte, T or C & Williamsburg, an express route to Doña Ana with connecting service with the Green Route or will be to operate Vanpool service with work and/or school trips to NMSU. Hatch will support this new service. Further details to follow.
