1. CALL TO ORDER

Nora Barraza called the meeting to order at approximately 1:30.

2. PLEDGE OF ALLEGIANCE

ALL STAND FOR THE PLEDGE OF ALLEGIANCE.

3. ROLL CALL

A quorum was determined to be present.

4. APPROVAL OF THE AGENDA

There were no changes to the agenda. Motioned by Councilor Flores, second by Mayor Murillo. Passed unanimously.

5. PUBLIC INPUT

Zach Mijares introduced himself as a Maintenance Department intern.

Matthew Arroyo introduced himself as a Maintenance Department intern.

Stacy Flores introduced herself as an Administrative Assistant intern, returning for her second year.

Joselyn Mendoza introduced herself as an Administrative intern.

David Armijo mentioned that he is pleased to have summer interns from the high schools and give the young people the opportunity to gain experience and good skills and thanked the County for providing the opportunity. Mayor Barraza has nine interns in the Town of Mesilla and is pleased with their performance.

6. APPROVAL OF SCRTD MEETING MINUTES OF April 26, 2023

There were no changes to the minutes. Motioned by Commissioner Sanchez, seconded by Mayor Murillo. Passed unanimously.

7. EXECUTIVE DIRECTOR'S REPORT

David Armijo gave the Executive Director's report and reminded the Board that the tentative budget for next year will be presented today, and the final budget will be done at next month's meeting. Some of Mr. Armijo's presentations will be in the Annual Report. The first two of the four buses that were ordered three years ago have arrived. Ridership is up 27.8% for the last 12 months. The majority of the riders use the Yellow Route to El Paso, Sunland Park, and Santa Teresa. The Red Route also did very well. The Green Route had over 6,000 riders. The numbers for 2016 through 2023 will all be presented in the Annual Report. In 2020, the pandemic reduced the numbers somewhat, but they have recovered well since then. Mr. Armijo hopes to increase service to Hatch and connect the Copper Route through Dona Ana, the MVITT Center, Mesilla Park, and the hospitals in Las Cruces. He and Loretta need to do more planning before that can be done. There should be no interference with RoadRUNNER Transit as well, even though they share stops and do cooperate. There are Public Service Announcements on KRWG and other spots to try to increase ridership.

There are annual grants from New Mexico DOT and this year it was over \$1 million. There are also competitive grants that help to purchase electric buses. Member agencies and Dona Ana County also provide operating capital. The New Mexico annual grant award includes over 20 transit agencies across the state. The State of New Mexico determines how much funding any agency gets based on performance. SCRTD was ranked third in the state for ridership this year, up from fourth last year; in administrative cost, the ratio was number eight; cost per trip was \$14.22, and per passenger trip was \$2.32; and was ranked number one for RTPO, and number one for budget expended at 100%. Overall SCRTD came out ranked first in the state. This is because SCRTD uses all its money carefully and there is little deadhead on any of those trips. Commissioner Sanchez was curious about how well the SCRTD is doing with the ten-year plan now that three years have passed. A graph was shown that demonstrated the difference between operating and capital monies, and which grants applied. There is overall about \$2 million in operating and \$8.4 million in capital. David Armijo has lobbied at the Legislature for the past several years and asked the Board Members to come up and help. Mayor Barraza recommended speaking to legislators before a session, around October, to have their full attention. Nathan Small is currently Chair of the Finance Committee. Legislative as well as local grants are available yearly and there are plans to transition to electric buses and solar power.

Commissioner Sanchez suggested having a booklet printed that gives an overview of the SCRTD and its activities.

8. RESOLUTION ACCEPTING TENTATIVE BUDGET APPROVAL FY2024 DISTRICT BUDGET

Adam Shea presented the tentative FY24 budget. It is tentative because some of the amounts are estimates because actual numbers are not available yet. Revenue is a 3.7% decrease of about \$100,000 due to higher expenditure. Capital appropriations have increased by 7.5%. There are a couple more vans for the vanpool, a few buses have been added, and funds from FY23 are being carried over due to multi-year grants. There are plans to rehabilitate the Anthony facility and five buses have been ordered, as well as plans for zero emissions that will come into play at a later date. A breakdown of operating revenue, dues, grants and MOUs, and amounts expected from the Texas 5307 funds was shown. Also, to be carried over from FY23 are bus fares, advertising, and DMV fees. Operating revenue is anticipated to be \$2.6 million, and expenditure is expected to be about \$2.4 million. That leaves almost \$200,000 in savings to be used for other things. The compensation study done for the state of New Mexico showed that SCRTD is at the bottom of the list of employees' pay. Therefore, it has been decided to raise employee pay and the expenditures listed in the presentation show that the amount of increase at a little over 10% over FY23. SCRTD also wants to increase the number of trips per day and the number of days per week in operation. This would increase the overall budget by roughly 12.9% for FY24. Employees received a wage increase last year of 5%. The cost of living had gone up by 8%. Mayor Barraza feels that a 10% raise is a bit much and asked if service would need to be cut to provide the increase. SCRTD currently has a surplus of revenue and there is a high turnover rate among new hires. After the 10% rise, it is projected that there will still be around \$200,000 surplus at the end of the year. Mayor Barraza is still worried about possible emergencies, as historically SCRTD has had to get loans to cover costs. The 10% raise would not even bring employees' salaries up to what they are in other areas of the state. Mayor Barraza feels that she needs to look at all the numbers and plan to gradually increase wages until, after several years, SCRTD employees can receive a competitive wage. Adam Shea will create percentage marks for Board Members to consider during the month of July. Councilor Flores is concerned with the sustainability of higher wages. Adam Shea reminded the Board that the 10% suggested increase would only be for FY24 and in subsequent years the increases would be lower percentages. The Texas 5307 funds are late coming in, causing the shortfall that necessitated going out for a loan to meet costs. It was suggested to make a motion to approve the tentative budget that included the COLA but put a hold on the extra 5% adjustment. Commissioner Sanchez would like to increase the wages but also provide transportation to the public for free. Nora Barraza added a third whereas to Resolution FY23-22: WHEREAS staff amend the proposed budget to only include a 5% cost of living adjustment and when the final budget comes before us, we will look at the additional 5% adjustment.

Motioned by Councilor Flores, seconded by Mayor Murillo. Passed unanimously.

9. FY2024 DISTRICT GRANT AWARD FROM NMDOT

David Armijo called the Board's attention to page 25 of their packet, under Budget Awards: FY23, Section 5311: Funding Distribution Index Rank. SCRTD is at the very top and because of performance, an extra 5% of funding is awarded for administration, which is \$8,161.94. There is also a 16% increase out of Federal Operating which is an additional \$82,548.36. This is all Federal funds of a total of \$90,709. Three agencies in the state also receive inter-city Federal funds: Las Cruces, Albuquerque, and Santa Fe. The additional \$90,709 is not in the budget that Adam Shea presented today but it will be included in next month's budget presentation. The MOU will be signed sometime in July which will itemize the amounts awarded. The Texas 5307 funds are over two years late, the monies have already been expended and compensated for, and so at least a part of that will be put in savings or a money market to earn interest.

ITEM #8: Discussion and Resolution Disposition of Obsolete Property - Sara Vasquez

The goal of this policy is to dispose of SCRTD property including but not limited to vehicles that the district has determined to be obsolete, worn-out, or unusable in a manner. The policy has been drafted to meet federal requirements for federally funded equipment and reviewed and approved by the NM DOT.

ITEM #9: Discussion of Appointment of District Property Disposal Committee

The Board Chair shall solicit volunteers from the Board at the Board meeting to fill the roles of committee members. To the extent possible the committee members shall represent diverse communities including, where possible, rural, and urban members along with tribe and pueblo members. The Property Disposal Committee shall meet at the time and location of its choosing. As long as the meeting facilitates the inspection and review of the property that the District intends to dispose of and provides a reasonable opportunity to determine the value of the property including physical inspection of vehicles. The Board may confer with staff and appropriate outside professionals on matters such as useful life, maintenance history, and potential resale value of the property.

ITEM #10: Discussion and Resolution Approving the Amended Drug and Alcohol Testing Policy.

The amended Drug and Alcohol Testing Policy reflects the most up-to-date elements of the policy as required by the Federal Transit Administration and is consistent with the New Mexico Department of Transportation requirements for Section 5311 Rural Transit providers.

ITEM #11: Discussion and Resolution Approving the FY24 ICIP Plan – Adam Shea

The ICIP plan has been updated to reflect the recent addition of federal funds to be used for multiple years within the plan.

ITEM #12: Discussion and Resolution Approving FY23 the end of the year fixed assets.

Included in the Board Agenda package are the annual end-of-the-year fixed assets. This reflects the aging of the bus fleet and properties as well as the inclusion of new equipment. The net result is that overall assets to the District have risen above 2.2 million dollars.

The district will provide an overview of the annual budget through the 4th quarter and will recommend modest changes to department accounts.
