
FTA Awards FY2022 Grant

- Federal grant is awarded on September 1, 2023
- Grant funds are for Fiscal Year 2022 plus five years for a six-year period
- The grant is now in year three.
- The first grant funds request is for roughly \$364,000 for the period October 1, 2021 through September 30, 2022.
- Grant funds are in the queue waiting for FTA to release.




FTA Approves NEPA & Grants Sunland Park Facility Grant Concurrence

- FTA Approves NEPA & Sunland Park Facility Concurrence
- This clears the way for the two parties to negotiate an agreement
- FTA requires legal counsel to conduct the negotiation for the District
- Carrillo has notified the District he is focusing on litigation work
- Staff is reviewing attorneys in the area

- The data includes service by hour, trip and miles






NMDOT Rural Transit System


Ridership FY19 – FY22

Unlinked Passenger Trip [UTP): 2019 - 2022




Vehicle Revenue Miles

Annual Vehicle Revenue Miles {VRM}: 2019 - 2022




Vehicle Revenue Hours

Annual Vehicle Revenue Hours {VRH): 2019 - 2022




Annual Vehicle Revenue Hours {VRH}

Operating Expense Vehicle Rev Hour




Vehicle Revenue Hour (VRH)


Annual Operating Expenses
